Applications are invited from eligible candidates for filling up of 4 (four) posts of Driver (ST-1, SC-1, SEBC-1 & Unreserved-1) in the Office of the Lokayukta, Odisha. The Post carries the scale of pay at Rs 19,900- 63,200/- (L-4). The appointment shall be initially on contractual basis and they will draw consolidated monthly remuneration as provided under Odisha Group-C & D Posts (Contractual Appointment) Rules, 2013 notified vide G.A Department Notification No. GAD-SC-RULES-0009-2013-32010/Gen dated 12th November 2013 and subsequent Amendment in GA & PG Department Notification No. GAD-SC-RULES-0037-2017-19574/Gen, dated 12th September 2017.

ELIGIBILITY

A candidate must -

- (i) have passed Higher Secondary School Certificate examination (10+2) or any equivalent examination from any recognised School, Board or Council, having valid Driving License authorised to drive light motor vehicle and experience of driving a Motor Car for at least three years, with basic knowledge in motor mechanism.
- (ii) be a citizen of India
- (iii) bearing a good moral character
- (iv) not have more than one spouse living, if married:
Provided, that the Lokayukta may, if satisfied that such marriage is permissible under the personal law applicable to such persons and the other party to the marriage and that there are other grounds for doing so, exempt such person from the operation of this regulation.
- (v) not have been involved or sent up or convicted in any crime.
- (vi) be of good mental condition and physical health, free from any physical defect likely to interfere with the discharge of his duties in the Service.
Provided, that the candidate who after such medical examination as the Government may prescribe, is not found to satisfy these requirements shall not be appointed to the service.

- (vii) be able to read, write and speak Odia and have
- passed Middle School examination with Odia as a language subject; or
 - passed Matriculation or equivalent examination with Odia as medium of examination in non-language subject; or
 - passed in Odia as language subject in the final examination of Class VII or above or
 - passed a test in Odia language of Middle English School Standard conducted by the School & Mass Education Department and
- (viii) not be less than twenty-one years and more than thirty-eight years of age on the date of application.

Provided that the upper age limit in respect of reserved categories candidates shall be relaxed in accordance with provisions of the Act, Rules, Orders or Instructions made by the Govt. for the time being in force, for their respective categories.

The applicant must furnish copies of the documents/ testimonials (self-attested) in support of their qualification/experience as per the above - mentioned eligibility criteria.

Selection Procedure:-


There will be a Selection test comprising of Written Examination and a Trade test.

The appointment shall be given to the selected candidates subject to their Medical Examination, antecedent verification and verification of documents/testimonials in original.

The candidates applying for the post must go through the detailed advertisement and ensure that they fulfil all the eligibility criteria prescribed for the post as laid down. If at any stage of recruitment or thereafter it is found that any information furnished by the candidate is false / incorrect or the candidate has suppressed any relevant information, his/her candidature for the post / examination will be cancelled forthwith.
